## CALL FOR THE MURAL CONTEST “A SEA OF SENSATIONS”

PARROTFISH RESTAURANT ROMANTIC ZONE IN PUERTO VALLARTA, JALISCO

### I. INTRODUCTION

ParrotFish Zona Romántica restaurant, operated by Delicias Narezushi, S.A. de C.V., invites artists and the public to participate in the “A Sea of Sensations” mural contest. The winning work will be displayed inside the restaurant following a colorful, fun, elegant marine theme.

### II. PARTICIPANTS

People over 18 years of age, of any nationality with a legal stay in Mexican territory. They can be teams or groups of people, however, they must name one as a representative. In the event that the winning participant or team does not reside in Puerto Vallarta, they must ensure that they can attend and participate in the implementation of the work in the restaurant, at their own expense only for transportation and lodging. The expenses for supplies and materials are borne by the ParrotFish Zona Romántica restaurant operated by Delicias Narezushi, S.A. de C.V., at its sole discretion.

### III. PARTICIPATION REQUIREMENTS

- a) Be of age
- b) Participate with an original and unpublished work.
- c) Compliance with laws and regulations regarding copyright and intellectual property.
- d) Upon receiving the work, an investigation will be carried out in the public Intellectual Property registries about the work and its copyright. Any indication of plagiarism (including without limitation the claim of a third party) will be causal to prevent participation in the contest.



### IV. DESCRIPTION OF THE THEME

The participating work must embody a sea of sensations, fusing elegance, color, and fun in a sensual and vibrant style in keeping with the ParrotFish brand.

### V. REGISTRATION AND SUBMISSION PROCESS

- a) The participant must send the sketch of his work in digital format via email to [concurso@parrotfishrestaurant.com](mailto:concurso@parrotfishrestaurant.com), including in the body of the email the technical sheet: full name, nationality, date of birth, contact telephone number, email, name of the work, technique, conceptual development, material, technical specifications.
- b) Use the provided graphic templates. Participants are fully responsible for any costs incurred to prepare the proposal with which they participate in the contest.
- c) Reception of works: August 22 to October 15, 2023 at 23:59 h.
- d) Applications by other means or extemporaneous will not be received.
- e) You will receive a folio by email at the end of the participation period. If you do not receive it, contact [concurso@parrotfishrestaurant.com](mailto:concurso@parrotfishrestaurant.com).
- f) Applications with incomplete information or not complying with the format established in subsection a) won't be considered.

## VI. SELECTION

- a) The winning entry will be selected by a committee appointed by the ParrotFish administration.
- b) Criteria to consider in the selection process: theme according to the call for shared templates, feasibility, technical, and artistic quality.
- c) The winner may not execute the work; the execution of the work is at ParrotFish's decision. The winner is the bearer of the idea.
- d) Announcement: November 1 on ParrotFish's official social networks and website  
 ParrotFishRestaurantZonaRomantica  parrotfishrestaurantpvr.  
On November 2 in Vallarta Opina. This decision will be final.

## VII. PRIZE

- a) The winning work participant will be a creditor of \$1,000 USD (equivalent in national currency), to be paid within the first 15 days after the publication of the winner. Payment of the prize may be subject to applicable tax withholding, or the winner may be required to issue a tax receipt.
- b) The winning idea will be awarded and must assign all the work rights to ParrotFish. The execution may or may not be carried out by the author. ParrotFish will decide who will execute according to the most convenient option at ParrotFish's discretion.

## VIII. RESPONSIBILITIES

- a) Assignment of rights to ParrotFish Zona Romantica. By participating in the contest and executing the work, the participant who is the winner irrevocably assigns and legally transfers the economic rights of the winning work in favor of Delicias Narezushi, S.A. de C.V.
- b) Adhere to applicable legislation.
- c) Assume the coordination and travel expenses on your own (for non-residents of Puerto Vallarta).

## IX. ACCEPTANCE OF THE RULES

- a) Participation implies acceptance of these bases.
- b) Any controversy concerning these bases, as well as on the occasion of the contest, its awarding, and the execution of the work or any other matter, will be resolved by the administration of ParrotFish. Its decisions being final.
